
Fulgent Sun International (Holding) Co., Ltd. ("Fulgent Sun", TWSE: 9802) today announced its unaudited sales for March 2020 was NT\$0.79 billion (+YoY 0.33%) on a consolidated basis. Consolidated sales for January through March 2020 totaled NT\$2.77 billion (+YoY 7.57%). Revenue in March and April over the years has been the low point due to the seasonal alternately period, although the revenue recognition in March is still affected by the epidemic and has deferred, the overall shipments of shoes in the spring and summer of 2020 (delivery period are between Q4 2019 and Q1 2020) have grown by nearly 20% over the same period last year.

However, since mid-to-late March, with the rapid deterioration of the Coronavirus (COVID-19) epidemic, forcing governments to execute more containment measures and stricter control of the flow of people and logistics, it directly affects most of the normal economic activities of the world, not only has it affected the smoothness of production and sales of Group's factories, but also led to the brand customers' attitude becoming more conservative towards placing orders. Therefore, although the Group's overall competitive advantage and background strength are still superior to the past and keep optimizing, the operational outlook for the next few months will still depend on the performance of the end consumer market and the degree of global epidemic control.
